The patient who believes that the amounts billed are for services insured under the Health Insurance Act can, within five years of payment, make a written claim for reimbursement to the Régie de l'assurance maladie du Québec. When it is of the opinion that the amounts billed are not allowed, the Régie reimburses the patient and recovers the same amount from the professional or third party who billed for the services.

^{**}This rate applies to copies the transmission required to obtain insured services, such as the transmission of patient chart notes to a new physician, when the patient asks his existing physician to transmit the documents for him.
